## Masters Swimming

**1<sup>st</sup> Annual Roy and Jean Potts Masters Swim Meet**

- Welcome:** Swim Belton invites you to join us at the Roy and Jean Potts Belton Swim Center to compete in the May SBMS Swim Meet. This meet is in short course yards.
- Facility:** The Roy and Jean Potts Belton Swim Center is located at 600 Lake Rd, Belton, Texas 76513 on the Belton High School Campus. This meet will be conducted in one, indoor, 8-lane, 25-yard pool using a Daktronics Timing System and Hy-Tek Meet Manager software. The pool has 7- foot lanes with a 5-foot minimum water depth. Telephone numbers: (254) 215-2444, (254) 718-7270, or (254) 939-1574. The facility has a separate 3-lane 25 yard pool with depths of 3'6" to 4'9", which will be available for continuous warm-up and cool down.
- Rules & Sanctions:** USMS INC., and South Texas Masters Swimming sanction this meet. Current USMS rules will govern the conduct of this meet.
- Meet Format:** Events will be seeded by time only. Men and women will swim together. All events will be timed finals. All events will be swum slowest to fastest unless otherwise noted. Meet management reserves the right to swim two swimmers per lane in events greater than 200 yds. Entrants are encouraged to include current seed times; swimmers with no seed times will be in the slowest heats.
- Meet Eligibility:** This meet is open only to registered United States Masters Swimming members current on the day of the meet. All swimmers must present their USMS registration card at check in. No pending registrations will be accepted
- Entry Limitations:** An individual swimmer may enter a maximum of 5 individual events.
- Deadline & Fees:** Entry fee is \$30 if received by Tuesday, May 12, 2009. No entry will be accepted after this date without payment of a \$10 late fee. Deck entries will be accepted with an entry fee of \$40. Make checks payable to **Swim Belton**.
- Entry:** Completed entry forms are to be mailed to Swim Belton, 7267 Woodlake Circle, Belton, Texas 76513. It is strongly encouraged that entries include a copy of their current USMS registration. Swimmers must present their current USMS registration at check in.
- WARM-UP:** General warm-up initial ½ or the warm up session, **NO DIVING OR RACING STARTS** allowed from the blocks or edge of the pool Swimmers must enter feet first cautiously. No sprint or race work allowed during general warm-up. Specific warm-up last ½ of the warm-up session will be racing starts only and lanes will be one way. Starts may be performed from the water, edge or blocks.
